At 9:30 A.M. President Chris Ruttger called the meeting to order. Jerry Hendricks led the BLIA with an opening prayer.

#### **Previous Minutes**

Minutes of the 2010 annual meeting had been posted on the BLIA website for 10 months, so copies were not distributed at the meeting. A motion was made and seconded to approve the minutes. The 2010 annual meeting minutes were approved.

#### **Treasurer's Report**

Chris Gondeck provided an audit report on the BLIA funds as of December 2010. He reported a balance of \$198,700 in cash and CDs. He reported that for 2010 revenue was down approximately \$40,000, and that this was on top of the reported revenue shortfall of \$29,000 for 2009.. Chris indicated that the audit report will be posted on the BLIA website.

A person attending the meeting asked if we were going to increase dues for membership. Chris Gondeck reported on discussions of such at Board meetings and indicated that there were no plans to increase dues.

A motion was made to approve the treasurer's report and this was seconded. Motion approved.

## **Committee Reports**

## **Membership Report**

Betty Marquardt reported that we have a membership goal for this year of 511 in 2011. She indicated that last year we had 501 members and that for 2011 we already have about 400 members. She encouraged lake residents to join the Association.

## **Aquatic Plant Management**

David Devins was unable to attend the meeting, but sent a report that was read by President Chris Rutger. The report indicated that we are continuing our fight against Eurasian Water Milfoil in Bay Lake as we have for almost 20 years now. The weather the last few years including this year has really worked in our favor. The fall treatments have been aggressive and very successful. Good snow cover and cool, more normal weather patterns have slowed the EWM growth. We are seeing native plant regeneration crowding out the EWM in many areas of the Lake in the last 2 years and hope for the same this year.

Last year we treated about 110 acres of EWM and the fall treatment as mentioned was very successful. This spring the weed growth is way behind normal due to the late ice out and the subsequent cool cloudy weather. We only treated about 8 acres this spring vs 37 acres last spring. With summer finally arriving expect the weeds to take off and try to catch up for lost ground but hopefully the native species will continue to outpace the EWM.

We are in a good spot right now because we were able to be extremely aggressive with fall treatments in 2006, 2007 and 2008. If you remember the EWM was very bad showing explosive growth. We were able to do that because we had the money to do so. Fortunately the weather shifted in our favor. Those hot dry years will cycle back but we have proven we can control the EWM keeping it from taking over the lake. We have been spending more money than we have been taking in the last few years. We just can't stop the fight and continue to need your support building our reserves back.

We are going to have a new Lake Vegetation Management Plan with the DNR in place this summer that will be even more flexible than what we have had. Something new on our agreement is we will be experimenting with several varieties of chemicals to see their effectiveness in areas that have been hard to treat.

We will send a letter, return post card and EWM and Zebra Mussel ID cards asking you to inspect your shoreline then report back by mailing the card to me (David). I go through them all and match the notes to the diver's findings and if they don't match we add treatment sites based on your findings.

Zebra Mussels are now in lakes in our area including Mille Lacs and Gull as well as the Mississippi and it is imperative we keep these out of Bay Lake. Watercraft inspections are the only way to keep it out. Phil and Jane Rollins have done a wonderful job of coordinating the access monitoring program so please volunteer and be part of the solution to keeping Zebra Mussels out of Bay Lake

As a reminder, signatures authorizing treatment within 150 feet of your property are required and we can't treat if we don't have them. Ask your neighbor if they have signed the form to make sure.

## **Access Monitoring**

Phil Rollins was unable to attend the meeting, but sent a report that was read by Vice President Doominic Cerisi. It was reported that the monitoring of boats coming into and leaving the lake began May 13 and that weekends since have been mostly covered. In mid-May, Phil sent an email to about 60 volunteers asking if they would help out again in 2011. Since then, I have called all those who did not respond to the email or do not have email addresses. Only one has asked to be taken off the list and that is for health concerns. We're scheduling into mid-June.

In early May Phil met with the new DNR intern, Ryan Abraham, who will be doing most of the DNR monitoring this summer. He's in school at N. Dakota State and working at Ruttger's.

Monitor training was held at Ruttgers on May 21 with about 12 Bay Lakers and 6 from Farm Island Lake. Another training is planned on July 9, the weekend after the BLIA Annual Meeting. This training gave us an important influx of new volunteers who are enthusiastic about helping in our efforts.

If you've been to the boat ramp, you know there are a series of signs warning of invasive species and that boaters' actions on the ramp are captured on camera. I'd like to purchase and have installed two additional signs in a strategic location to better get the attention of boaters as they approach the ramp. The cost of the two signs, plus installation would be about \$350; if we do the install, about \$150 for the signs. I'd opt to have the iLids folks do the install so it gets done ASAP.

With the discovery of Zebra Mussels in Gull, this threat becomes ever more likely and our efforts to monitor boats that much more important. If you have not had the DNR monitor training, please consider attending the July 9 training and giving a few hours on the ramp this summer

#### **Water Quality**

Mark Roloff provided an update on last year's winter water quality sample, what the Association is doing to prevent runoff on County Road. 10 around the lake, and a reminder that leaves should not be raked or blown into the lake this fall.

#### **Development**

Patricia Jespersen and Dominic Ciresi Reported on the status of the Development Fund (previously called the Environmental Fund. They reported a shortfall of funds needed for continued water quality and aquatic plant management activities. Dominic and Trish provided a detailed explanation of how funds are used by BLIA and encouraged increased contributions to the fund.

#### **Dock Regulations**

Jerry Poland reported on the status of efforts by state and federal agencies to limit dock sizes on lakes. He indicated that many of the docks currently on Bay Lake exceed government planned space.

#### **Shoreline Preservation**

Tiffin Trip thanked members for participating in the shoreline plant and tree giveaway on Memorial Day weekend. She indicated that new people are needed to help with the giveaway and that more members need to participate.

# **Children's Party**

Mina Gallagher indicated that the 2011 Childrens' Party is scheduled for today, July 2 on Church Island. The party is held at Bay Lake Camp and cost of the party is \$200.

## **Golf Tournament/Picnic**

George Reynolds indicated that the date of the golf tournament and Bay Lake Picnic is August 13. He indicated that forms would be distributed via mail within the next couple of weeks.

The four nominees were elected.
