Minutes

AIS Prevention and Detection

Phil Rollins reported that we are learning more of what the county, DNR and other lakes are doing to prevent ZM infestation. It was agreed that Phil would research hiring scuba divers to inspect areas around the public accesses of Bay Lake. He will also speak with Buddy Divers, who does the diving for Bay Lakes Milfoil treatment and Jack Gadbois who does private diving. Phil will find out what the cost would be to have them come and do an underwater survey of about 1 acre. Phil recommends we them come the week of July 19th to do a free survey off the accesses and give us an estimate of the cost. Phil suggests we have this done twice a month. Amy Grady suggested we use Jack Gadbois because he is local and an experienced diver. There was discussion of the continued use of inspectors and other ZM detection devises. Phil said we are in a better position for 2016.
